Facility Use Policies and Procedures: Gymnasium

Initial

- _____ 1. New Life Church reserves the right to deny rental if use does not agree with the church's mission.
- _____ 2. Rental includes the gymnasium and bathrooms only, which does NOT include the commons or kitchen areas.
- _____ 3. Renters shall be at least 21 years of age and shall be present during the event. The person signing the rental agreement will be considered the responsible party in case of damage, theft, or disturbances during the rental event. The Renter is responsible for the actuarial cost of repairs for any and all damages to facilities or grounds during the rental event. Up to 15% administrative charge may be assessed in addition to the cost for repairs.
- _____ 4. Renter is responsible for the supervision and control of the individuals attending the event, to prevent injury and ensure safety before, during and after use of the facility. NLCC staff reserve the right to intervene if it is deemed that the event supervision is inadequate.
- _____ 5. Absolutely no smoking or use of alcoholic beverages in any part of the New Life Community Center facility.
- _____ 6. Renter may have access to volleyball and pickleball nets, basketballs, volleyballs, bathrooms and showers. Towels, lockers, hair dryers, soaps and shampoos are not provided.
- _____ 7. Appropriate attire is required including shirts and athletic shoes with non-marking soles. NO BLACK soled shoes are permitted.
- _____ 8. No food or drink are allowed, except water or sports drinks in a sealed container.
- _____ 9. Behavior and language are to align with NLCC guiding principles.

INDEMNIFICATION AGREEMENT

The Renter agrees to defend, indemnify and hold harmless the New Life Community Center, its employees and agents from and against any and all liability, loss, costs, damage and expense, including costs and attorney fees in defense thereof because of actions, claims, or lawsuits for damages resulting from personal bodily injury, including death at any time resulting therefrom, sustained or alleged to have been sustained by any

person or persons on account of damage to property, arising or alleged to have arisen directly or indirectly out of or in consequence of the permitted use.
