1. New Life Church reserves the right to deny rental if use does not agree with the nurch's mission.
2. Rental includes the gymnasium and bathrooms only, which does NOT include the ommons or kitchen areas.
3. Renters shall be at least 21 years of age and shall be present during the event. The erson signing the rental agreement will be considered the responsible party in case of damage, eft, or disturbances during the rental event. The Renter is responsible for the actuarial cost of epairs for any and all damages to facilities or grounds during the rental event. Up to 15% dministrative charge may be assessed in addition to the cost for repairs.
4. Renter is responsible for the supervision and control of the individuals attending the vent, to prevent injury and ensure safety before, during and after use of the facility. NLCC staff serve the right to intervene if it is deemed that the event supervision is inadequate.
5. Absolutely no smoking or use of alcoholic beverages in any part of the New Life ommunity Center facility.
6. Renter may have access to volleyball and pickleball nets, basketballs, volleyballs, athrooms and showers. Towels, lockers, hair dryers, soaps and shampoos are not provided.
